Parents,

We're excited to welcome back our students on October 19th! To clarify, the schedule will be as follows:

October 19th: Freshmen A Group (8:55am-4:05pm)

October 20th: Freshmen B Group (8:55am-4:05pm)

October 19th and 20th will be remote learning days for 10th-12th graders.

During these days, we will spend time with students explaining all of the protocols for safe learning in-person. This will include:

- The importance of staying home if a student feels sick
- The requirement of wearing a mask and the proper way to do so
- Our plans for limiting hallway traffic (staggered release times, directional flows of hallways, and restrooms assigned to specific classrooms)
- The importance of social distancing when in rooms or hallways with others
- Protocols for the lunch period, which includes reserving a seat and maintaining social distance
- Procedures to follow if a student feels sick at school

We also want to make these transition days fun! That's why we have activities planned to help our freshmen get to know one another (*socially distanced, of course*), to learn more about the clubs and activities available at Poudre High School, and to meet the staff who are here to support them during their first year of high school.

Expectations as We Transition to In-Person Learning:

Student Expectations

- Students and/or parents will check for signs and symptoms daily.
- Students who are sick must stay home.
- Students will honor school procedures for safety--hallway directional flows, seating assignments, assigned entrances and exits, wearing masks, and social distancing.
- Students who cannot uphold the rules for safety will be sent home to engage in their learning remotely.

Parent Expectations

- Complete symptom checks for your children every day.
- Keep your children home if they are sick or show COVID-19 symptoms.
- Provide your children with masks and teach them how to wear and care for masks.
- Remind your children to maintain safe social distancing.
- Remind your children to wash their hands frequently.
- Honor school procedures for school arrival and departure and school guidelines for visitors.
- Communicate with the school regarding cases and potential exposures.
- Assist your children with accessing teacher learning pages and online learning platforms.

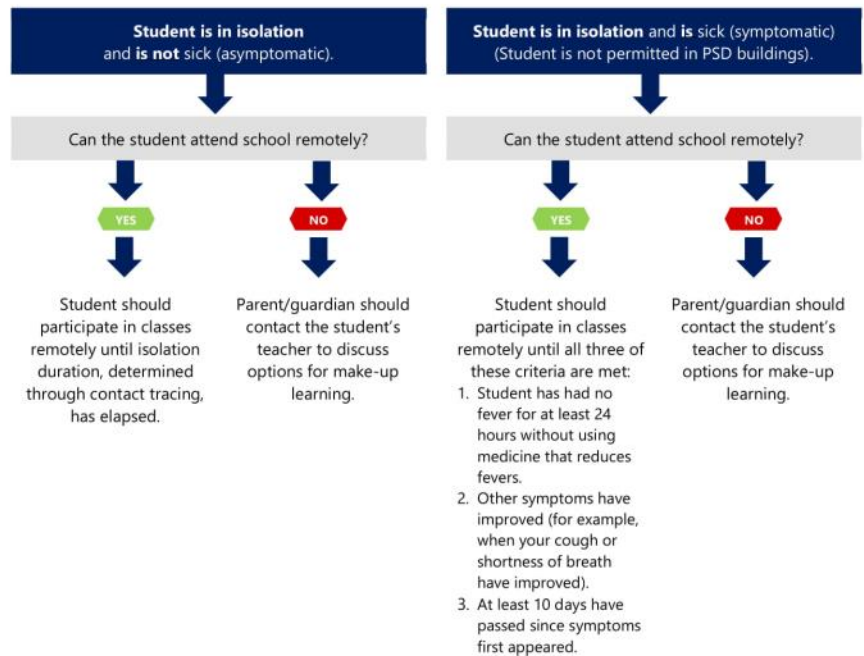

Protocols for Students COVID Workflow

Is your student not feeling well? **FOLLOW THESE STEPS** and **DO NOT SEND YOUR STUDENT TO SCHOOL**:

1. Contact your student's school attendance line to alert the school that your student will be absent. Please leave a message on this line indicating that your student is ill, may be experiencing COVID-19 symptoms (if this is the case), and/or has been tested for COVID-19.
2. Contact the School Nurse/Health Tech using the phone number provided on the attendance line and leave a message with information about your student's circumstances.
3. You will be contacted by the school nurse/health tech and/or PSD's contact tracing liaison or county health contract tracers to answer some specific questions and with next steps to follow.
4. If you have not already done so, contact your student's health care provider.

PSD will protect the privacy of individuals through the entire process.

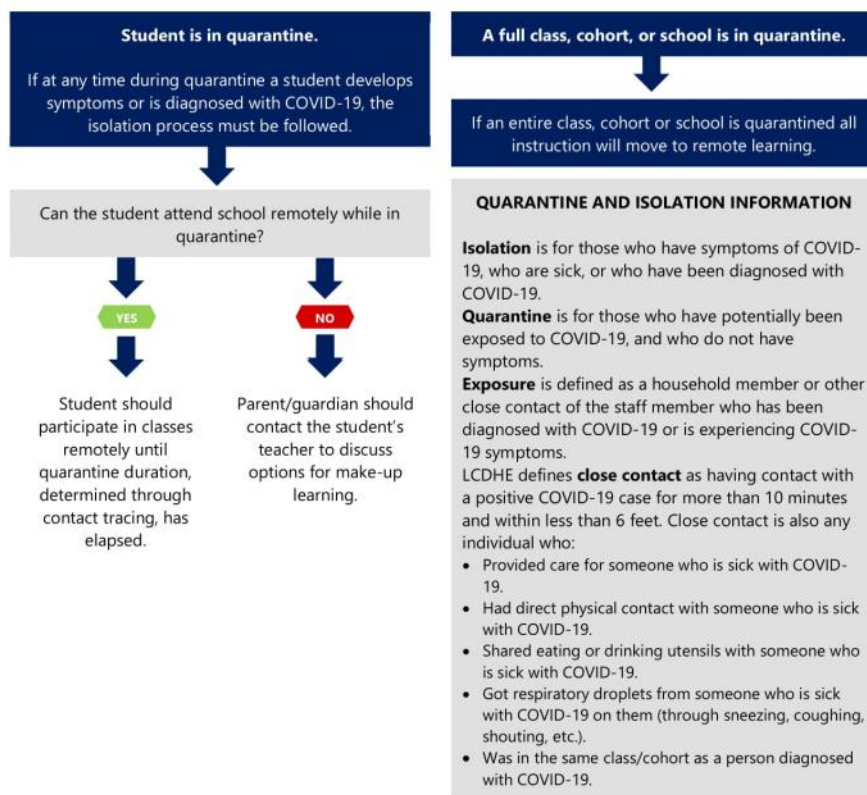

COVID-19 GUIDANCE

Can I go to school today?

At-home symptom screening for parents and staff

Parents and guardians can use these symptom checklists to determine when to keep their child at home based on the level of COVID-19 transmission in their community (e.g. Is the community in Protect Your Neighbor or Safer at Home or Stay at Home). School staff can also use this tool to determine if they need to stay at home. **Any student or staff diagnosed with COVID-19 or who is a close contact of a COVID-19 case should not go to school and should isolate or quarantine according to public health recommendations.**

These lists refer only to new symptoms or a change in usual symptoms. A student/ staff should not be kept home for usual symptoms they experience due to a chronic condition unless they are worse than usual. These guidelines are in addition to your regular school guidance (for example, a child with vomiting should also not attend school based on usual school guidance).

If your child is/ you are experiencing any potentially life-threatening symptoms please call 911.

Low Community Transmission (Protect Your Neighbors):
 If any of the following symptoms are present, keep the child at home/ stay at home, inform the school of symptoms, and reach out to a health care provider about COVID-19 testing and next steps for treatment.

- ☐ Feeling feverish, having chills, or temperature 100.4°F or higher.
- ☐ New or unexplained persistent cough.
- ☐ Shortness of breath.
- ☐ Difficulty breathing.
- ☐ Loss of taste or smell.

Sustained Community Transmission (Safer at Home or Stay at Home):
 If any of the following symptoms are present, keep the child at home/ stay at home, inform the school of symptoms, and reach out to a health care provider about COVID-19 testing and next steps for treatment.

- ☐ Feeling feverish, having chills, or temperature 100.4°F or higher.
- ☐ New or unexplained persistent cough.
- ☐ Shortness of breath.
- ☐ Difficulty breathing.
- ☐ Loss of taste or smell.
- ☐ Fatigue.
- ☐ Muscle aches.
- ☐ Headache.
- ☐ Sore throat.
- ☐ Nausea or vomiting.
- ☐ Diarrhea.
- ☐ Runny nose or congestion.

COVID-19 At-home symptom screening for parents UPDATED 08/10/20

Transportation:

- Transportation staff are working hard to get routes designed and students assigned to routes for our K-2 restart on Oct 5th and the remaining students on October 19th.
- When routes are ready to be shared with the community, families will be provided with their transportation information and shared with schools.
- It is likely that K-2 (maybe K-5) families will be notified first, then 6-12 in the following weeks leading up to Oct 19th.

Bus Capacity is Limited:

To ensure social distancing, only 22 students are allowed on a bus. PSD has created a 1:22 Ratio Priority List--

- Students with transportation services in IEP
- Students receiving support and services through the McKinney-Vento Act.
- Students in foster homes in need of transportation.
- Learning Priorities
- Vulnerability & Distance

SAT Exams

Attention Class of 2021 - SENIORS

It's here! After months of quarantine, the SAT has made it to Fort Collins, CO.

Poudre High School will administer the SAT exam for all seniors on Wednesday, October 14, 2020. Registration is not required. Students will complete this <https://forms.gle/XdfztocWuvt34vZ38> to indicate their interest for the optional essay of the SAT exam. This information will be sent to their PSD email account. The exam will begin at 9 am at Poudre High School. PSD Transportation is still working out logistics with COVID in hopes to provide transportation for students. Both parents and seniors will receive more information via email.

PSAT (11th graders): Oct. 29 (no make-up date)

**students will be registered by PHS for each exam based on their grade level therefore, students do not need to register for the exam themselves.*

Fall Administration for SAT and PSAT

Fall administration for **12th grade SAT** will be Wed, October 14, 2020 at PHS and
11th grade PSAT will be Wed, October 29, 2020 at PHS.

These assessments provide students the opportunity to take the SAT or PSAT in place of the spring 2020 SAT and PSAT school-day exams that were not administered. Test dates may be canceled in the event of a local or regional school closure related to the COVID-19 pandemic. In the event of closure, additional test dates are not expected to be scheduled, but students may have the option to take the assessment on a Saturday administration.

Please note that this date is assigned by College Board and falls on the last week of our academic semester.

The make-up date for 12th grade SAT is Oct. 27th. Seniors who need to be in class on Oct. 14th can take the SAT on Oct. 27th, the make-up date. There is no make-up date offered for the PSAT for 11th graders.

FAQs

- **Do students need to register to take the exam?**
 - No. All PHS students are automatically enrolled for the exam, regardless if they plan to take it or not. Our PHS students include our Impalas who are PSD Virtual this year.
- **Will the district provide transportation?**
 - This information has not been confirmed at this time. As soon as we receive this information, we will communicate it to both students and staff.

Important Reminders from the School Nurses

As we prepare to transition from online learning to hybrid/in-person learning it is important that you let us know about your child's health concerns.

Your child is unique. Please give us the details that will help us be of assistance to your child at school. If he/she has a health concern, contact your school health office. Information you provide will be reviewed by the school nurse and a Health Care Plan may be developed.

Medication at School

All medication given at school, whether doctor prescribed or over the counter, must be accompanied by PSD Authorization to Administer medication form (available on the PSD website under the Parent, tab, Health services), signed by both the parent/guardian and the physician. Medication must be provided and brought to school by a parent, in the original prescription bottle or over the counter container. Pharmacists may provide you with two bottles if you ask them to label one for school use. If medication changes or medication is discontinued during the school year, please have the child's doctor fax us the new or correct orders.

Authorization for medication administration **MUST BE COMPLETED YEARLY** and health care plans updated annually.

Phone Numbers

It is important that we have your home and work phone numbers, as well as emergency contact(s) and phone numbers(s). Should your child become ill or hurt while at school, we **MUST** be able to reach you. If changes occur during the school year, please notify the school office.

Schedule changes

2nd quarter schedule changes are available until Wednesday, October 21, 2020.

The last day to withdraw from classes will be Friday, October 23, after that a withdraw results in F.

Make sure to schedule in advance to meet with your counselor for schedule changes.

Seniors: Please schedule a **senior conference** with your counselor in October. This conference will review your graduation status and the planning process for your postsecondary goals.

College Application Information

Counselors will help students with the college application process during their **senior conference**. PHS will send official transcripts, school reports, and counselor recommendations (as required) to the colleges that students are applying to. These components are required for each application.

- For Common App applications invite your counselor in your common app account.
- For Coalition App applications invite your counselor in your coalition account.
- For University specific applications request your transcript in Xello.

Pay the Transcript Fee via School Pay, <https://psdschools.schoolpay.com/>

- \$3.00 one-time for Common App and Coalition App applications.
- \$3.00 for each University application
- Fee waived for students receiving free/reduced lunch. If you need assistance please talk with your school counselor for accommodations to help with college fees.

Pay careful attention to the college application deadlines. Counselors need a minimum of TWO WEEKS prior to any application deadline to complete the school report and counselor recommendation.

Does your application require teacher recommendations? Make the request in person and in your college application, giving the teachers a minimum of TWO WEEKS prior to any application deadline to complete the teacher evaluation and recommendation.

Applying for financial aid? For students starting college in Fall 2021 the Free Application for Federal Student Aid (FAFSA) will be available starting October 1, 2020. Follow the specific college's recommendation as to when it should be completed by. <https://fafsa.ed.gov/index.htm>

To inspire more Coloradans to continue their education, all 32 public colleges and universities in Colorado and several private institutions will allow students to apply for free on Tuesday, Oct. 13 as part of the third Colorado Free Application Day.

Colorado Free Application Day caps off Colorado Applies Month, a five-week campaign that guides 11th- and 12-grade students and adult job seekers along the application process. **Admissions application information for each institution will be available on the campaign website soon, and fees will be waived for applications submitted on Oct. 13 only.**

The high school graduating class of 2021 will also have the option to include or not include their SAT or ACT scores with their college applications as Colorado colleges have implemented a “test-optional” policy making the college application process even easier for students this year. The statewide push is designed to increase Colorado's stagnant college-going and FAFSA completion rates. Despite being one of the most educated states in the country, Colorado sends just 56 percent of high school graduates to a college, university or certificate program, and just 50 percent of students submit a FAFSA application—a key indicator of students' likelihood to continue their education.

By removing barriers for students to achieve a credential, Colorado can increase the number of students who complete their programs and enter the workforce with a degree or competitive skills. Nearly 75 percent of Colorado jobs require a postsecondary credential. Colorado Free Application Day encourages residents to live up to their fullest potential.

If you forget your password, it cannot be recovered. You will need to start over on the form if that happens.

- When the form is complete with all signatures, click SUBMIT and a copy of the form will be directed to you, your parent, your high school counseling office, and the school district.
- Final Steps:
 - If you are enrolling in the High School Select program (classes at your high school), no additional steps are needed.
 - If you are enrolling in the Campus Select program (classes on FRCC campus), you will need to complete an online orientation and register for your classes before the first day of classes.

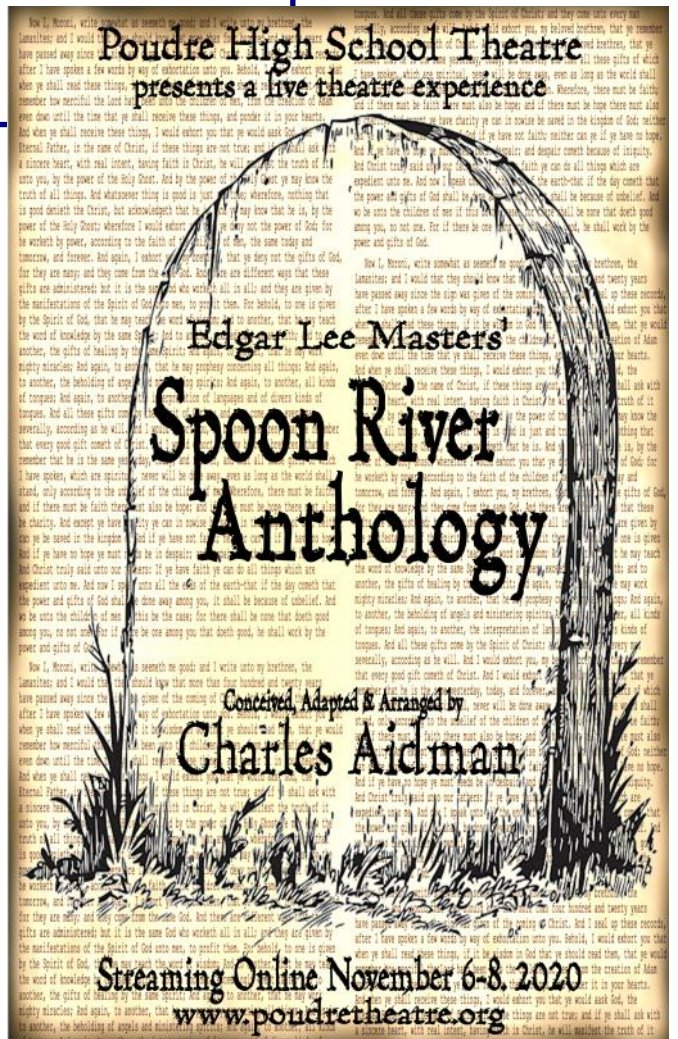

Compensation starts at \$13.25/hour. As students will work towards their MMSC certification, they will receive a \$0.25/hour increase for each of the four MSSC modules they complete for a pay of \$14.25/hour.

Students must be 16 years or older before January 2021 and at least a high school junior in the 2020-2021 school year.

What You Will Do:

Manufacturing Production Technicians set up, test, adjust and run manufacturing machinery and equipment. You will inspect and test both equipment and finished products for flaws. If flaws or failures arise, you will notify the appropriate staff (e.g., supervisors, quality control staff) and help determine the cause of the problem. 5 or less – examples are below. Set up and operate production equipment in accordance with standard operating procedures. Inspect and adjust equipment to ensure quality production, using tools such as calipers, micrometers, height gauges, protractors, or ring gauges. Set up and verify functionality of safety equipment. Troubleshoot problems with equipment, devices, or products. Start up and shut down processing equipment.

Beyond Consequences & Advanced Parenting Skills Class

Beyond Consequences is a unique, relationship-based approach to parenting traumatized children and those with attachment challenges. This approach provides a trauma-informed explanation of “acting out” behaviors. Caregivers will learn how children escalate through behaviors, as well as how to respond to help their children during these times. When children and caregivers expand their ability to emotionally tolerate stressful situations, behavior naturally improves. The class is appropriate for biological parents, adoptive parents, foster parents, and kinship-care providers.

One-on-one coaching sessions are included with this program.

Some Topics Addressed in This Program:

- Emotional regulation and dysregulation
- Window of stress tolerance
- Trauma and memory
- Acting out behaviors (i.e. lying, stealing, aggression, etc.)
- Signs and stages of verbal and behavioral escalation

- Setting appropriate and enforceable limits
